Job Focus

• Work under the management and supervision of Senior HSE Technician.

- Assist the Senior HSE Technician in ensuring the health and safety of Briggs employees, contractors, clients, visitors, and the general public where they can be affected by our business.
- Main focus is HSE provision at Burton, and at Prestonpans as required.
- Assist the Lead HSE Technician in their duties for the standards applied on project sites.

Main Tasks & Responsibilities

Specific duties:

- Data collection, population of spreadsheets and formulation of reports as required by the HSE Department.
- Weekly, monthly and periodic inspections in line with legal and Briggs standards eg ladder inspections
- Oversee the pre-use check sheet process and rectification.
- Oversee the HSE "onboarding process" for new starters.
- Oversee the DSE requirements for the organisation.
- Oversee the "Work at Home" assessments.
- Ensuring intranet and notice boards are kept relevant and up to date.
- Publication of HSE updates through email and newsletters etc.
- Perform manufacturing and site audits, raise non-conformances, and assist in rectification.
- Provide updated insurance details to interested parties when requested.
- Undertake toolbox talks.
- Standardise site HSE signage across manufacturing and office operations.
- Implement suitable and adequate hazard identification, assessment, and controls.
- Review, approve or escalate, subcontractor RAMS
- Assist individuals in their understanding of duties under the health and safety policy.
- Advise where the Company may be in breach of any statutory duty, and make recommendation as to the necessary corrective and preventative actions.
- Organise waste streams in line with environmental good practice

General duties:

- Assist the HSE team in the management of sub-contractors and their safe working practices.
- Assist in the coaching, mentoring and training of employees and contractors.
- Work with managers and other key staff to establish and maintain a programme of continuous improvement in the management of health, safety and wellbeing.
- Assist in the investigation of accidents/incidents and remedial actions.
- Assist in the preparation of RAMS for both manufacturing and project engineering activities.
- Support the Senior HSE Technician in the fulfilment of their duties and responsibilities and advise, where necessary, where Briggs Health and Safety standards are, or could, be compromised.
